

***OWNERS ACKNOWLEDGEMENT OF NEEDED REPAIRS***

**Work Authorization:** I hereby authorize the repair of the vehicle identified below by A-1 Body & Frame. I agree that A-1 Body & Frame is not responsible for loss or damage to the vehicle or articles left in the vehicle in case of fire, theft or any other cause beyond your control or for any delays caused by the unavailability of parts or shipping delays. I also hereby grant permission to A-1 Body & Frame's employees to operate this vehicle for the purpose of testing, transporting for related work, or inspection. A-1 Body & Frame reserves the right to repair this vehicle at any of our facilities. An expressed mechanic's lien is hereby acknowledged on the vehicle to secure the amount of repairs thereto, and I further agree to pay reasonable attorney's fees and court costs in the event legal action is necessary to enforce this contract.

**Terms:** I acknowledge that the total estimate of repairs includes all parts, labor, handling and diagnosis and agree that if closer analysis finds that additional repairs are necessary, in the event all repairs do not exceed the estimate by (10%), excluding tax, I authorize A-1 Body & Frame to perform such work or repairs and I agree to pay for them. I will be contacted for authorization if the amount I must pay exceeds the estimate by more than (10%) excluding tax. If I choose not to have such additional repairs made, I will remain liable for any repairs performed regardless of whether my vehicle is completely repaired. Accepted method of payment includes insurance checks, cash, cashier's check, MasterCard, or VISA. ***Personal Checks Are Not Accepted***

**Power of Attorney:** For consideration of repairs made to this vehicle, I hereby grant by Power of Attorney to sign or endorse any checks and/or drafts made payable to me and any release thereto, as settlement for my claim for damage to this vehicle.
